The length of the grant is set by the grant committee at the selection session. Depending on the project in question and on the applicant's work schedule, grants can be paid generally for between one and ten months, in the case of full doctoral programmes in Germany for up to three years, and in

- Support can only be provided for the completion of a full doctoral programme in Germany when special support policy reasons exist. Such reasons include, for example, the lack of comparable research or academic supervision opportunities in the home country or when the doctoral topic
- Support for full doctoral programmes in Germany is based on a programme length of three years; if foreign graduates first have to qualify for admission to a doctoral programme, then grants can be awarded for a period of four years. Even when support has been awarded for a full doctoral programme, that award will initially be limited to a maximum of one year. Extensions then depend on whether or not the evaluation finds the previous award period to have been successfully completed.

# Value

- DAAD generally will pay an appropriate flat-rate travel allowance, unless these costs are covered Depending on the award holder's academic level, the DAAD will pay a monthly award of 750 euros (graduates holding a first degree) or 1,000 euros (doctoral candidates). As a rule, the scholarship additionally includes certain payments towards health insurance cover in Germany. Furthermore, the home country or by another funding source.
- Award holders completing a stay of more than six months receive a study and research allowance plus, where appropriate, a rent subsidy and family allowance. Funding for attendance of a language course is decided on a case-by-case basis (cf. Requirements).

Depending on the country of origin of applicants, for example, special conditions prevailing in the home country education system, etc., exceptions are possible. At the time of application, generally no more than six years should have passed since gaining the last degree; in the case of doctoral students, no more than three years should have passed since starting

These study scholarships aim to provide foreign applicants from the fields of Fine Art, Design, Film, Music, Architecture as well as Performing Arts (Drama, Direction, Dance, Choreography, etc.) with an opportunity to complete a course of extension studies, without gaining a formal degree or qualification, or to complete a postgraduate or Master's degree course to gain a degree in Germany (Master's/Diplom), at a German state (public) or state-recognised higher education institution.

# Additional Information on DAAD Study Scholarships in the Field of Music

Academic studies in musicology are offered by universities only. Scholarship applicants for this subject do not apply in the separate process for music, but rather pass through the general process applicable to all academic subjects.

DAAD study scholarships in the field of music are only awarded for extension studies. Applicants must generally hold a first academic degree; if this is not possible, they should at least have exhausted all the training options offered for their instrument in their home country. At the time of application, they must not have been resident in Germany for more than one year.

This university is also responsible for organising practical courses with universities, companies and, possibly, public institutions (Study Seminars and Practicals),
- facilitate meetings with German students, academics and researchers to establish and maintain contacts between German and foreign universities,
- give students a greater understanding of and insight (regional and area studies) into economic, political and cultural life in Germany. The part must not make up more than one third of the
- one direction only. In the case of Study Seminars and Practicals, the programme strives for reciprocity, although this is not a condition for the award of funding. This means that funding can initially be provided for visits in

# of Natural and Technical Sciences, Agriculture and Forestry Practical Traineeships for Foreign Students

### Objective

Practical training placements for students of the above mentioned subjects are arranged by the International Association for the Exchange of Students for Technical Experience (IAESTE). Placements are, however, only available to countries with a National IAESTE Committee. Within the DAAD, unit 514 is the German National IAESTE Committee.

### Duration

Usually, traineeships are two to three months in duration with various firms, institutions of higher education and research institutes. In individual cases, traineeships of extended duration can be arranged.

#### Value

Trainees are usually paid  $\in$  650,— per month; all incoming trainees will be included in the health insurance, accident insurance and liability insurance provided by the DAAD. The DAAD, however, is not able to grant additional funds to cover travel costs.
